5 **(1) Effective January 1, 2015, each health insurer or health care service contractor**  
6 **offering:**

8 [*(1) Effective January 1, 2015, each health insurer offering qualified*] **(a) Qualified** health plans  
9 through the Marketplace shall pay a monthly administrative charge equal to \$9.66 times the  
10 number of members enrolled through the Marketplace in that month.

11  
12 [*(2) Effective January 1, 2015, each health insurer offering stand*] **(b) Stand** alone dental plans  
13 through the Marketplace shall pay a monthly administrative charge equal to \$0.97 times the  
14 number of members enrolled through the Marketplace in that month.

16 **(2) Effective January 1, 2016, each health insurer or health care service contractor**  
17 **offering:**

19 **(a) Qualified health plans through the Marketplace shall pay a monthly administrative**  
20 **charge equal to \$9.66 times the number of members enrolled through the Marketplace in**  
21 **that month.**

23 **(b) Stand alone dental plans through the Marketplace shall pay a monthly administrative**  
24 **charge equal to \$0.97 times the number of members enrolled through the Marketplace in**  
25 **that month.**

27 **(3) Effective January 1, 2017, each health insurer or health care service contractor**  
28 **offering:**

30 **(a) Qualified health plans through the Marketplace shall pay a monthly administrative**  
31 **charge equal to \$6.00 times the number of members enrolled through the Marketplace in**  
32 **that month.**

34 **(b) Stand alone dental plans through the Marketplace shall pay a monthly administrative**  
35 **charge equal to \$0.57 times the number of members enrolled through the Marketplace in**  
36 **that month.**
