This chart provides only an estimate of an individual or family's likely eligibility. The Oregon Health Plan begins using 2024 federal poverty levels to consider eligibility on March 1, 2024. The Marketplace begins using 2024 federal poverty levels on Nov. 1, 2024 for the 2025 plan year. This chart is valid Nov. 1, 2024 to Feb. 28, 2025.
