A wor noum chon angang me pwan ka mochen awora insurens?

En ka tongeni angang fengen fiti emon chon angangen insurens ika chon awora insurens ren eom kopwe angei ewe fichin pwonupwonun mwich ren noum kewe chon angang. Ekkoch kukun bisinis kena repwene nafeno ren ew tax credit ren an epwe anisir ne moni ren pwonupwon ika pwe ra kan moni ew plan mei afateno.

Ika pwe kose kan awora insurens ngeni noum chon angang kena, iwe pesei ngenir ar repwe angei pwonupwonun emon me emon seni non HealthCare.gov, ikewe meni ir repwene nafeno ren aninisin moni ren an epew anisir ne moni ekkewe momon ren pwonupwon.

Met ngang uwa nafeno ren ewe Small Business Health Care Tax Credit?

Ewe IRS Small Business Health Care Tax Credit a kan anisi kukun bisinis kena ra nafeno ren ar repwene akoturatiw ewe mon ren kaworen health insurens ngeni noun chon angang kena. Oregon kukun bisinis kena repwene kan tori ekkewe awukukun tekiakisin tetenin kena ra tapweto ren ar repwe nafeno ren ewe tax credit:

- Chon angang ra kan chokukun seni 25 chon angang kena ra kan full-time equivalent (FTE) (esapw pachenong chon ani ewe bisinis we family/chiechien kena ika chon angang kena non chok fansoun season kena ina ir ra angang kukun seni 120 ran nupwen ewe fansoun a tongeni takises non ewe ier)
- Moni awukukun niwinir kena iteiten ier ren \$56,000 ika kukun seni ren emon me emon chon angang
- Moni esapw kis seni 50 percent ren FTE an chon angang kena mon premium kena
- Moni ew mei afateno plan ren safei ika ngii seni ew insurens kompeni mei fitinong

Met epwene fis ika emon chon angang ese mochen ai we kaworen insurens?

Ika pwe ewe insurens plan ka awora a tori ekkoch sakkun awukuk kena ren ar repwe tongeni moni me pwan pwonupwonun, nge emon chon angang a finata an esapw sainita ren ena, iwe ewe chon angang a tongeni sainita ren ew plan non HealthCare.gov nupwen ewe attun fansoun suukunon katonong (Nov. 1 to Jan. 15). Achema ngeni noum chon angang kena pwe ir resapw nafeno ren monien aninis.

Met ngang upwene awora insurens ngeni nei chon angang kena?

Ika pwe ka angei chokukun seni 50 chon angang kena ra kan full-time equivalent (FTE), iwe en kosapw pwan kan awora insurens, me pwan en kosapw sap ngeni pakingino ren eom kose aworano ena. Nenien angang kena ir ra angei 50 ika chomonganen FTEs repwene fofor ngeni ew paking ika pwe ir rese kan awora pwonupwonun health insurens ir ra tongeni monir ina ra tori awukukunon wukukun pwonupwonur kena ren nour chon angang kena. Pwonupwon ra tongeni monir a kan pwonupwon ina mor kena esapw nap seni 9.02 percent seni an emon chon angang we monitorong iteiten ier non 2025.

Paking kena seni ewe IRS ra kan akapacheno usun ekkei ra tapweto:

- Ese wor pwonupwon ra aworano: \$2,500 x (FTEs – 30) ew ier
- Pwonupwon ra aworano, nge esapw ew ra tongeni moni ika ese kan tori ewe awukukun mor kena ra mochen: Kukunun seni ewe kapach me asan ika \$3,750 x FTEs ika a angei ew Advanced Premium Tax Credit

META EI KAMON PWONUPWON?

Ekkena kukun bisinis non Oregon fiti emon tori 50 chon angang kena ra tongeni moni ew plan mei afateno wenewen seni ew seni ekkewe chon awora insurens ra fitinong. Ika pwa ka eani ew kukun bisinis fiti chokukunon seni 25 chon angang kena ir ra angang unusek fansoun, iwe meni en kopwene nafeno ren ewe Small Business Health Care Tax Credit. **Eomuwe bisinis a nafeno ren SHOP ika pwe en ka:**

- Angei ew ofes ika nenien chon angang me non an ewe SHOP we nenien aninis.
- Angei 50 ika chokukunon chon angangan FTE kena.
- Awora pwonupwon ngeni meinisin noum kewe FTE chon angang kena (ra angang arapakan 30 ika nap seni awa kena ew wiik).
- Katonong non esapw kis seni 70 percent seni noum kewe FTE chon angang kena non eomuwe SHOP plan. Chon angang kena fiti

pwonupwon seni non an pwan ew nenien angang plan, Medicare, Medicaid, ewe pekin sonfiu, ika programen sonfiu kena seni mwan rese kan pachenong non ewe akapachen.

(Nenien angang kena ina ir ra kan katonong non pwonupwonun SHOP nefinen Nov. 15 me pwan Dec. 15 ew me ew ier ra tongeni awora pwonupwonun SHOP nge ika mo pwe rese tori ei percentin ra mochen.)

Ren awewe, ika pwe ew nenien angang a angei 50 chon angang kena, 21 seni ekkena ra angei pwonupwon seni non HealthCare.gov, me pwan ese kan aworano pwonupwon ina a kan tori ekkewe met ra mochen, iwe ewe nenien angang epwene kan moni ew paking ren \$50,000 (\$2,500 x 20 = \$50,000). Churi irs.gov ren eom kopwe kaeo chomong usun ewe Employer Shared Responsibility Payment.

Met ngang upwene awora pwonupwon ren punuwen me pwan noun chon angang kena?

Apw, nge ika pwe en kose kan tongen eom kopwe awora health insurens ren punuwen me pwan noun noum chon angang kena, iwe ir repwene nafeno ren monien aninis ren ar repwe moni ewe mon ren health care. Ese wor pakingen takises ren eomuwe bisinis ika pwe ir ra angei monien aninis. Ir ra tongeni katonong me non **HealthCare.gov** ika seni ar korior **800-318-2596** (ewe wor mon) ren ar repwe katonong. Ir ra pwan tongeni churi **OregonHealthCare.gov** ika kori **855-268-3767** (ese wor mon) ren ar repwe kuuta emon chon sineinapen insurens non nenier ren an epwe anisir ne kuuta ewe fichin plan.
