HealthCare.gov. Ewe Oregon Health Authority
(OHA) a kan pwan tinawow ekkoch taropwe
ngeni ekkena ir ra kan pwonupwonuno seni ewe
Akoten Safean Oregon (Oregon Health Plan,
OHP) ika Children's Health Insurance Program

Q: Met ngang upwene angei echo taropwen 1095?

A: Ika pwe en ka kan tonong non pwonupwonun safei non ekkena fansoun nupwen ewe ier, iwe en kopwene angei echo Taropwen 1095-A, 1095-B ika 1095-C. Ika pwe kose kan angei pwonupwon, iwe en kosapw angei echo taropwen 1095.

Q: Met ngang upwene angei napeno seni echo taropwe?

A: Meni. En a kan fichino eom kopwe angei napeno seni echo taropwe ika pwe ekkena seni ekkei ra tapweto ra kan aeoeo ngeni:

- En ka angei pwonupwon seni napseni ew nenien angaiin.
- En ka kan angang ngeni napseni ew nenien angang ina ra awora pwonupwon.
- En ka asiwinin pwonupwon ika nenien angang nupwen ewe ier.
- Sakonon chon non eom family kena ra angei pwonupwon seni sakonon nenien angaiin kena.

Nounou meinisin ekkewe taropwe ka angei ren eom kopwe awasano eomuwe federal tax return ren eom kopwe pwarano pwe en ka angei pwonupwon ra mochen.

Q: Met upwene fori ika pwe uwa:

- Angei ew kapaseis usun ewe taropwe uwa angei?
- Ekkieki pwe upwene fen angei echo taropwe nge use kan angei ena?
- Mochen echo asiwinin taropwe?
- Nuku pwe ewe taropwe uwa angei a kan angei ew mwanino?

A: Kori ewe chon awora ewe taropwe, ika ewe nenii ka ekkieki pwe epwene fen tin ngonuk echo taropwe.

- Ren kapaseis kena usun Taropwe 1095-A, kori **HealthCare.gov** non **800-318-2596** (ese momo).

- Ren kapaseis kena usun Taropwe 1095-B, kori ewe chon awora pwonupwon (nengeni line 18 seni noumuwe Taropwe 1095-B ren ew nampan fon kopwe kori).

- Ren kapaseis kena usun Taropwe 1095-C, kori eomuwe nenien angang (nengeni line 10 seni noumuwe Taropwe 1095-C ren ew nampan fon kopwe kori).

Q: Met ngang upwene fofori ai upwe fileni ew tax return ika pwe uwa angei echo seni ekkei taropwe?

A: Unusenapen, ika pwe ka angei Taropwe 1095-A, apwarano amutirinon momon premium tax credit ren pwonupwon remw ika emon noum, iwe en kopwene kan filen echo noum emon takesisin monitonong return seni nounoun Taropwe 8962. Nge ew chok, en kosapw fofori eom kopwe filen ew tax return pokiten chok en ka angei Taropwe 1095-B ika Taropwe 1095C. Ren awewe, ika pwe ka kan tonong non Medicaid, iwe en kopwene angei echo Taropwen 1095-B.

Q: Met epwene fis ika pwe uwa fileno nge use nounou nei we 1095-A, 1095-B ika 1095-C?

A: Ika pwe en kose repotini pwe en ka fen angei pwonupwon won eomuwe 2018 ika me mwan tax return, iwe meni en kopwene moni ewe paking ren eom kose kan angei insurensin safei. Pwan, ika pwe ka angei tax credits kena me pwan kose kan repotini ewe poraus seni ekkewe taropwen 1095 won eomuwe tax return ika kose filen eom tax return, iwe ewe IRS epwene tin ngonuk Taropwen 5591 ika 5596. Ewe taropwe a kan awora afanefanen kena won ifa usun eom kopwe apungu ewe osupwang. Ika pwe kose kan apungu ewe osupwang, iwe meni kopwene fen aniwinan meinisin tax credits kena ngeni ewe federal government. En meni kose pwan angei tax credits kena ren insurensin safei ewe ier murin.

Q: Ika pwe en kose kan aeoeo ren premium tax credits kena non ewe ier a no ika nounou ekkena ren koturetiwen ai premium iteiten maram, met uwa tongeni kleiminir won ai kewe takises?

A: Ika pwe en ka fen tonong non pwonupwonun safei seni non HealthCare.gov, iwe en kopwene angei echo taropwen 1095-A. En ka tongeni eada ewe poraus won ena taropwe me pwan seni ewe online Health Coverage Tax Tool ren eom kopwe amasowawow taropwe 8962 won eom kena takises. Ika pwe en ka nafeno ren tax credits kena, iwe repwene kan apachenong ngeni eom momo sefan ika aturatiw eom takises ka niwinimangeno..
