**Bael:** Ñe kwar kanne am peba ilo HealthCare.gov, kwar lelok tarrin joñan kolla eo am. HealthCare.gov ear kōjerbal melele in ñan bwinne am maron töbrak ñan kredit in ewoj eo kin jejjetin wonnen injuran aoleb allõñ. Ekkar lab am maron kōjerbal "kolla ko rekkar lewaj maanlok" kin ewoj in kredit in ñan kadiklok jejjetin wonnen injuran eo kwōj kollaiki aoleb allõñ.

Ilo ien kwar bael ae peba in ewoj eo am ikjen kolla an federal, jejjetin wonnen eo kwōj kollaiki ālikata ikjen kredit in ewoj kwōmaron töbrak ñane enaj ekkar ñan jejjetin kolla eo am iloan iiõ eo. Oregon Health Authority (OHA) ej bar jilkinlok peba ko ñan jabdewõt eo ekkar injuran ibben Oregon Health Plan (OHP) ak Children's Health Insurance Program (CHIP). Ilo jet wāween ko, armij ro ewör aer injuran in Medicare iomwin Paat A (injuran in wonnen aubitol) renaj loe peba 1095-B.



Peba 1095-B im Peba 1095-C ekoba ejja melele ko:

- Kain injuran
- Etan armij ro kwōj bök eddoier im redeloñ ilo injuran eo
- Ien aer deloñ ilo injuran

**Bael:** Peba ko ijin lõñ rej kamool ke kwe im armij ro kwōj bök eddoier emõj aer bök minimum essential coverage (joñan injuran eo aurok im ediktata joñan, MEC) im ej mennin aikuj iomwin Affordable Care Act (Kakien eo ej kadiklok wonnen injuran). Rej jibañ kamool ke kwōban bakkin kin an ejellok am injuran ilo ien am bael ae peba in ewoj eo am ikjen kolla ibben federal ñan iiõ in ewoj ko ilo 2018 im moktalok.

**K: Inaj ke loe juon peba in 1095?**

**U:** Ñe emōj kadeloñ etam ilo injuran in taktō ilo jabdewōt ien iloan iiõ eo, kwōj aikuj loe juon Peba 1095-A, 1095-B, ak 1095-C. Ñe ejellok am kar injuran, kwōban loe juon peba 1095.

**K: Inaj ke loe elablok jen juon peba?**

**U:** Bolen. Emaron lablok jen juon peba kwōnaj loe elañe jabdewōt wāween kein rejimwe:

- Ekkar wōr am injuran jen elablok en juon jikin.
- Kwar jerbal ibben elōñlok jen juon jikin jerbal eo ear lewaj injuran.
- Kwar jañij injuran ak jikin jerbal iloan iiõ eo.
- Oktak armij ro ilo baamle eo am rar ebōk aer injuran jen jikin ko roktak.

Kōjerbal aoleb peba kein kwōj loe ñan kadedelok peba in eowoj eo am ibben federal ñan kwalok ke kwar bōk injuran eo ej mennin aikuj.

**K: Ta eo ij aikuj kömmane elañe ewōr aõ:**

- Ewōr kajjitōk kin peba eo ikkar loe?
- Lomnak ij aikuj kar loe juon peba bōtab ikkar jab loe?
- Aikuj ke bar juon peba?
- Tōmak peba eo iar loe ewōr juon bōd ae?

**U:** Kebaak jikin eo ej lewaj injuran ilo peba eo, ñe ejab jikin eo kwōj lomnak aikuj kar jilkinwaj juon am peba.

- Ñan kajjitōk ko kin Peba 1095-B, kebaak jikin eo ej lewaj injuran (lale lain 18 ilo Peba 1095-B eo am ñan nomba in talebon eo kwōnaj kall ae).

- Ñan kajjitōk ko kin Peba 1095-C, kebaak jikin jerbal eo am (lale lain 10 ilo Peba 1095-C eo am ñan nomba in talebon eo kwōnaj kall ae).

**K: Ij ke aikuj bael peba in eowoj elañe iar loe juon ian peba kein?**

**U:** Ekkā, ñe kwar loe Peba 1095-A, ej kwalok an iwōj kolla ko an kredit in eowoj ñan jejjetin wonnen injuran aoleb allōñ ñan injuran eo am ak juon armij eo kwōj bōk eddoin, kwōj aikuj bael ae peba in eowoj in kolla eo an juon armij ilo am kōjerbal Peba 8962. Bōtab, kwōjab aikuj bael peba in eowoj wōt kinke kwar loe Peba 1095-B ak Peba 1095-C. Ñan waan joñak, ñe emōj kadeloñ etam ilo Medicaid, kwōnaj loe Peba 1095-B.

**K: Ak ñe ikar bael peba ilo aõ jab kōjerbal peba in 1095-A, 1095-B, ak 1095-C eo aõ?**

**U:** Ñe kwōjab ripoot ke ewōr am injuran in taktō ilo peba in eowoj eo am ilo 2018 ak moktalok, kwōmaron aikuj kollaiki bakkin eo kin an ejellok am injuran in taktō. Im bareinwōt, ñe kwar loe kredit in eowoj ko im kwar jab ripooete melele eo jen peba 1095 ko ilo peba in eowoj eo am ak likjab in bael ae peba in eowoj eo am, IRS enaj jilkjinwaj Leta 5591 ak 5596. Leta eo ej lewaj kōmelele ko kin wāween am kajimwe bōd in. Ñe kwōjab kajimwe bōd in, kwōmaron aikuj karool aoleb kredit in eowoj ko ñan kien eo an federal. Kwōmaron bar jab loe kredit in eowoj ko ñan injuran in taktō ilo iiõ eo juon.
