Background from the Centers for Medicare and Medicaid Services (CMS)

On May 2, 2024, the U.S. Department of Health and Human Services, through the CMS, published a final rule to modify the definition of "lawfully present" applicable to eligibility for enrollment in a Qualified Health Plan (QHP) through the Health Insurance Marketplace and a Basic Health Program (BHP). With this modification, DACA recipients and other non-citizen groups will no longer be excluded from that definition, thereby making it possible, effective November 1, 2024, for DACA recipients who meet all other eligibility requirements to enroll in:

(1) a QHP through the Marketplace with financial assistance like advance payments of the premium tax credit (APTC) and cost-sharing reductions (CSRs) or

(2) a BHP.

What does this mean?

Starting November 1, 2024, DACA recipients will be considered lawfully present for Marketplace and Oregon Health Plan (OHP) Bridge – Basic Health Program coverage and, if they meet all other eligibility requirements, will be eligible to enroll in a health plan through the Marketplace with financial assistance such as advanced premium tax credits (APTC) and cost-sharing reductions (CSRs) or OHP Bridge, Oregon's Basic Health Program.

Does this change only impact DACA recipients?

This change impacts:

- People with Deferred Action for Childhood Arrivals (DACA) status;
- People with pending applications for asylum; and
- People with an employment authorization that did not previously qualify.

Marketplace timelines

 Newly eligible individuals, including DACA recipients, will qualify for a special enrollment period (SEP) to enroll in a health plan through the Marketplace during the 60 days following November 1, 2024. Consumers who apply for coverage through a SEP during November 2024 can have their Marketplace coverage begin as early as December 1, 2024, if they meet all other eligibility requirements.

- Consumers who apply for coverage before December 15, 2024 through open enrollment can have their coverage begin as early as January 1, 2025, if they meet all other eligibility requirements.
- Consumers who apply for coverage between December 16, 2024 and January 15, 2025 can have their coverage begin February 1, 2025.
- For DACA recipients who are eligible for a BHP, coverage could begin as early as December 1, 2024.
- DACA recipients who enroll in a health plan under a SEP for coverage starting
 December 1, 2024 must also actively enroll in a health plan during open enrollment for coverage starting January 1, 2025. Their December coverage will not automatically reenroll for 2025.

OHP Bridge – Basic Health Program timelines

- Consumers who are found eligible for OHP Bridge between November 1 and November 15, 2024 will have coverage starting December 1, 2024.
- Consumers who are found eligible for OHP Bridge between November 16 and December 15, 2024 will have coverage starting January 1, 2025.
- There is a continual activation period between the 16th of the month and the 15th of the next month for coverage beginning the first of the following month.

More Oregonians now qualify for health coverage and financial help

Eligibility rules changed on Nov. 1, 2024, which means more people can get covered through OregonHealthCare.gov and Oregon Health Plan (OHP) Bridge – Basic Health Program.

Starting Nov. 1, 2024, DACA recipients are eligible to enroll in health coverage if they meet other eligibility requirements. Coverage can begin as early as Dec. 1 for individuals who act before Nov. 15.

OHP Plus benefits are still available to eligible people in Oregon regardless of immigration status.

There are multiple ways to apply for coverage, depending on what you may qualify for. No matter where you start, you will be referred to the right program for you. Help is available in many languages. All relay calls are accepted.
