OHP Plus kak kohda ohng ser ikan oh aramas laud sohte lipilipil ia mwomwen arail pidelong nan wehi. OHP Plus kin apwalih epwel pen imwen wini, wia ngih, oh roson mwahu en mwohmwun mwekimwekid. Tohn pwihn kin kak ale ekei kamwahu kan, me duwehte peidaid ohng tuong toahkte oh sahpis teikan ohng roson mwahu. OHP Plus sohte kin mie isepe ohng tohn pwihn. Met wehweki sohte anahne pwain, sohte iang pwain pweipwei kan, sohte pwain insurens oh pweine teikan.
