Deferred Action for Childhood Arrivals (DACA) a cih bang a hiam?

DACA pen federal sepkhiatna khat hi a, kumpi ciaptahna lai a neilo mi pawlkhat kipuakkikna (deport) a thuak loh na ding un nasem uhhi. Hih gamdangmi te pen United States ah a neu lai pek un ong tung uh ahihi. DACA asangte pen nasem thei uh a, sang zong kah thei uh hi. DACA pen a tawntung a ding hilo hi. Kum nih sim in a thak bawl kik kul hi.



Oregon Health Plan (OHP) pen bang a hi hiam?

Oregon Health Plan (OHP) pen Oregon i Cidamna lam panpihna (Medicaid) sepkhiatna hi a, A cidam zaw Oregon (Healthier Oregon) ong hih nang zong kihel hi. OHP Plus pen gamdang mi hihna dinmun te ki en lo in, naupang te leh kumcing sa khangno te a ding ki ngah thei hi. OHP Plus ah zato lam, ha cidamna lam, leh gamtat luheek tawh kisai cidamna lam khoina cih te kihel gai hi. Pawllut te a ding adang hamphatna te a hi, zatolam kimuhna te leh cidamna lam panpihna te a pai a ciah na ding uh ki vaihawm sak lai ding hi. OHP Plus ah pawllut man piakkul lo hi. Tua a hih man in, premiums, co-payments (sumpiak kulna), coinsurance leh deductible (dokkul sum) te cih bang om nawn lo ding hi.



OHP Bridge a cih bang hiam?

Oregon Health Plan (OHP) Bridge pen OHP Plus ngeina kiciangtan zah sang a tam zaw sumlut a nei kumcing khin khangno te ading cidamna coverage hamphatna nam thak khat a hihi. Tua na ngah theih nang in gamdang mi hih theihna dinmun khat na neih kul ding a, tun ahih leh DACA a sangte zong kihel ding hi. OHP Bridge ah hun saupi panpihna te kihel lo a, khua hun, inn leh lo, ahikheileh pumpi ading cidamna lam hamphatna te a ding zong kihel lo hi. OHP Plus bang mah in, OHP Bridge ah pawllut man om lo hi.



Marketplace (Vanzuakna phual) a cih bang hiam?

Oregon Cidamna Aamahkhan Vanzuakna phual pen Oregonian (Oregon a tengte) te'n mimal neih cidamna aamahkhan plan te tehkak in minkhum theih na ding in a huh ding a hihi. Hih pen minkhum sa te'n cidamna coverage leh khoina te a ding sumpiakna ah huhna a ngah theih na ding uh mun a hihi. Marketplace pen state tawh nasem khawm a, OHP Plus leh OHP Bridge a ngah thei ding mi te min piak sak hi. Tua na ngah theih nang in gamdang mi hih theihna dinmun khat na neih kul ding a, tun ahih leh DACA a sangte zong kihel ding hi.

- Si sitna, x-ray, leh zatui dawn ding hilhcianna.
- Ki pattah kikna leh huhpiakna lam panpihna te
- Lungsim cidamna leh zatui zang te khoina
- Naupang te ading ha lam leh mit lam khoina.
