8 (1) Effective January 1, 2015, each health insurer or health care service contractor offering:
9

10 (a) Qualified health plans through the Marketplace shall pay a monthly administrative charge equal to
11 \$9.66 times the number of members enrolled through the Marketplace in that month.
12

13 (b) Stand alone dental plans through the Marketplace shall pay a monthly administrative charge equal
14 to \$0.97 times the number of members enrolled through the Marketplace in that month.
15

16 (2) Effective January 1, 2016, each health insurer or health care service contractor offering:
17

18 (a) Qualified health plans through the Marketplace shall pay a monthly administrative charge equal to
19 \$9.66 times the number of members enrolled through the Marketplace in that month
20

21 (b) Stand alone dental plans through the Marketplace shall pay a monthly administrative charge equal
22 to \$0.97 times the number of members enrolled through the Marketplace in that month.
23

24 (3) Effective January 1, 2017, each health insurer or health care service contractor offering:
25

26 (a) Qualified health plans through the Marketplace shall pay a monthly administrative charge equal to
27 \$6.00 times the number of members enrolled through the Marketplace in that month.
28

29 (b) Stand alone dental plans through the Marketplace shall pay a monthly administrative charge equal
30 to \$0.57 times the number of members enrolled through the Marketplace in that month.
31

32 (4) Effective January 1, 2018, each health insurer or health care service contractor offering:
33

34 (a) Qualified health plans through the Marketplace shall pay a monthly administrative charge equal to
35 \$6.00 times the number of members enrolled through the Marketplace in that month.
36

37 (b) Stand alone dental plans through the Marketplace shall pay a monthly administrative charge equal
38 to \$0.57 times the number of members enrolled through the Marketplace in that month.
39

40 (5) Effective January 1, 2020, each health insurer or health care service contractor offering:
41

42 (a) Qualified health plans through the Marketplace shall pay a monthly administrative charge equal to
43 \$5.50 times the number of members enrolled through the Marketplace in that month.
44

45 (b) Stand alone dental plans through the Marketplace shall pay a monthly administrative charge equal
46 to \$0.36 times the number of members enrolled through the Marketplace in that month.
47

48 **(6) Effective January 1, 2021, each health insurer or health care service contractor offering:**

50 **(a) Qualified health plans through the Marketplace shall pay a monthly administrative charge**
