Q: If I am not eligible for OHP benefits anymore, when can I enroll through the Marketplace?

A: We recommend enrolling through the Marketplace before your OHP benefits end to avoid a gap in coverage and care. You may enroll through the Marketplace until July 31, 2024 if you lost OHP benefits between March 31, 2023 and July 31, 2024. Coverage will start the first of the month after you enroll.

Q: Can I get help paying for health coverage?

A: Yes. Last year, more than seven out of 10 people in Oregon who bought insurance on HealthCare.gov got help paying for coverage. Find out how much you can save at **[OregonHealthCare.gov/WindowShop](https://www.oregonhealthcare.gov/WindowShop)**.

Q: How do I find the best plan?

A: Here are the most important things to consider:

- Think about the type of care you need.
- Think about any doctors or hospitals you want to keep visiting, as well as any prescriptions you need covered.
- Think about how much you can spend, and look for plans that fit your budget. Consider the monthly payment, deductibles, and co-pays.

Last day to sign up for health coverage through HealthCare.gov until the annual open enrollment period.

NOV. 1 TO JAN. 15

Annual open enrollment period. If you don't sign up, you could go a year without insurance.
